As we attempt to endure life stresses, some of us are able to take them in stride and not become ill or feel out of control because we have discovered meaningful ways to decrease our stress levels. Others succumb to such stressors and become physically ill or emotionally distraught to the point of exhibiting signs and symptoms indicative of feeling out of control. Psycho-emotional reactions to life stresses may appear as physical symptoms such as asthma, chronic abdominal, neck, or back pain, migraines, irritable bowel syndromes, muscle tension, or starvation. Physical functioning problems are frequently accompanied by depression, anxiety, or agorophobia.

This workshop will focus on the social context for emotional and physical illness, how the sick role gets played out within the family system and society at large, the meaning of noncompliance in maintaining illness, issues of secondary gain, and personality factors which seem related to illnesses. The treatment of psychosomatic problems will be addressed by exploring crisis intervention, effective methods of treatment, and specific disorders, especially those seen on the Comprehensive Medical Unit at Stanford Hospital. Case examples will be used to illustrate specific problems and approaches that have helped to effectively reduce psychological and physical symptoms.

PRESIDENT'S NESSAGE:

I've just returned from a CAMFT Board Meeting in Long Beach and want to share with you my impressions of what's happening on the State Level. A Big Coup! Our State organization has made a Participating Provider Agreement with Blue Shield! Blue Shield will publish a list of preferred providers (MFCC's) received from CAMFT. This agreement points the way for future preferred provider agreements and underscores the importance of belonging to our professional organization who will furnish the lists. This should be a strong incentive for licensees to join us.

Prospects for passing SB1331 are looking good. Victims, family members, witnesses of violent crime are eligible for psychotherapy expenses up to \$2,300 paid for by the state. (SB1331-Victims Compensation/psychotherapy MFCC's). SB137 makes sex with a patient a crime. Currently, it is not. The BBSE revoked 16 licenses last year. Fourteen were of MFCC's for having sex with a client. The BBSE intends to hold hearings on this issue soon. We discussed the status of 15 bills at this Board Meeting; some of which help us and some that threaten our status.

We are offering suggestions regarding regulatory changes to the BBSE about continuing education and tighter supervision of interns. The BBSE has solicited our help in this matter. Regulatory changes in both these areas will probably occur in the near future. The BBSE will begin publishing a regular newsletter soon.

The National Association of Social Workers has approached us about establishing a working relationship and supporting our legislation. We have worked hard to gain this alliance.

CAMFT, via Dick Leslie, and our lobbyist using our funds (Special Issues & PAC) stay on top of the legslature situation. They develop more political clout with every year that passes. We are fortunate to have Dick's expertise behind us as the security and scope of our license is constantly subjected to challenge and attack.

The Board also reviewed the financial status of CAMFT, which looks sound and strong. We discussed plans for the 1986 Conference at Irvine. (Norma Etter is working on the State Conference Planning Committee.) We picked a site for the 1987 Conference in Northern CA: the new Marriott's opening soon in Burlingame.

We discussed <u>much</u>, <u>much</u> more; an upcoming membership drive, Chapter interface, writing a chapter handbook, public relations, <u>The Therapist</u>, office reorganization and procedures which are shaping up well since we hired Mary Riermersma, our new Executive Director. We set policy and made decisions for about 17 hours at this last meeting. It was interesting, exciting, tiring and a lot of responsibility. Over half the Board is new, and for a first session we are working smoothly together. The prevailing directions are: To be responsible to the membership, to tighten up our procedures, and to act with integrity in making every decision.

NEW LAWS CONCERNING CHILDREN -- By Marti Baerg

- 1. <u>Child abuse reporting requirements</u> have been tightened by raising the fine for not reporting to \$1,000. MFCC's have civil non-liability for reporting. If sued for reporting, you may claim reimbursement of attorney fees from the State Board of Control.
- 2. <u>Child snatching laws</u> as of 1/1/85 better protect the children of newly separated parents. Last year such parents without a court order in effect had a "right of custody" defense to any child snatching prosecution. That defense has been eliminated and any parent who steals children with the intention to deprive another of custody may be criminally prosecuted.

THE BASICS OF NFCC LICENSING -- By John Thompson

- . An appropriate advanced degree is required.
- . After the advanced degree, 3,000 hours of experience are required before the written exam can be taken.
- . After passing a comprehensive written test, you are allowed to take the oral examination.
- . Passing the oral examination qualifies you to use the title "Marriage, Family and Child Counselor."

For all of us who have gone through these steps (at least the majority of us who weren't "grandfathered/grandmothered"), we need to reflect on the meaning of the licensing process in the professions. The process doesn't guarantee that a person is a good therapist, but merely provides for minimum competency. On the other hand, provisions are made in the California laws for psychotherapists that those who aren't licensed can't practice without certain provisions. Some of the provisions for those without licenses are:

- . Supervision is required.
- Supervision consists of one hour per week for each week of experience claimed toward the 3,000 hours required for qualifying for the written examination.
- . Interns (those who have completed the graduate degree) must be registered with the Board prior to performing any duties.
- . The unlicensed counselor must inform each client or patient prior to performing any counseling functions that he or she is unlicensed and is under supervision.
- It is illegal (and could jeopardize your being licensed) to advertise in such a way that implies that you are a licensed counselor.

For those of you who have just gone through the oral exams and now qualify as Licensed Marriage, Family and Child Counselors, congratulations! Part of being a professional is having uniform standards that are incorporated in the selection process. For those of you who are "pre-licensed", I'm sure that the efforts you're going through right now to attain the goal of being a licensed professional are worthwhile.
